AN ACT

- Amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in Pennsylvania Game Commission, further providing 2 for organization of commission; in game or wildlife 3 protection, further providing for regulations, for report to 4 commission officer, for surrender of carcass to commission 5 officer and for unlawful activities; and, in hunting and 6 furtaking, repealing provisions relating to hunting on Sunday 7 prohibited, further providing for unlawful devices and methods and for the offense of trespass on private property 8 9 while hunting and repealing provisions relating to hunting on 10 11 Sunday without written permission. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- 14 Section 1. Section 301(a) of Title 34 of the Pennsylvania
- 15 Consolidated Statutes is amended and the section is amended by
- 16 adding subsections to read:
- 17 Organization of commission. § 301.
- 18 Composition. -- [The] Subject to subsection (b.1), the
- 19 independent administrative commission known as the Pennsylvania
- 20 Game Commission shall consist of nine competent citizens of this
- 21 Commonwealth who shall be well informed on the subject of
- 22 wildlife conservation and restoration and who shall be appointed
- 23 by the Governor, by and with the advice and consent of a

- 1 majority of the elected members of the Senate.

- 3 (b.1) Additional consideration. -- The Governor shall ensure
- 4 that at least one member of the commission represents the
- 5 <u>interest of agricultural commodities that pertain to normal</u>
- 6 <u>agricultural operations and wildlife.</u>

- 8 (e) Definitions. -- As used in this section, the following
- 9 words and phrases shall have the meanings given to them in this
- 10 subsection unless the context clearly indicates otherwise:
- 11 "Agricultural commodity." As defined in section 2 of the act
- 12 of June 10, 1982 (P.L.454, No.133), referred to as the Right-to-
- 13 Farm Law.
- 14 "Normal agricultural operation." As defined in section 2 of
- 15 the Right-to-Farm Law.
- 16 Section 2. Sections 2102(b)(2), 2122 and 2125 of Title 34
- 17 are amended to read:
- 18 § 2102. Regulations.

- 20 (b) Seasons, possession, bag limits and devices.--
- 21 * * *
- 22 (2) If in any year the commission fails to establish
- 23 seasons or bag limits or fails to establish other hunting or
- furtaking regulations under authority of this title, the open
- 25 seasons and bag limits for game or furbearers[, Sundays
- 26 excepted], unless otherwise provided by this title, and all
- 27 other hunting or furtaking regulations adopted under
- authority of this title, shall be the same as set by
- 29 regulation of the commission for the previous license year,
- and all seasons shall open and close one calendar day earlier

- 1 than the previous license year. In the event the commission
- 2 fails to establish seasons and bag limits for a license year
- 3 beginning in a leap year, the seasons shall open and close
- 4 two calendar days earlier than the previous license year.

- 6 § 2122. Report to commission officer.
- 7 Any person who kills any game or wildlife, other than
- 8 raccoons, under the provisions of this subchapter shall, within
- 9 24 hours, report, orally or in writing, the killing to an
- 10 officer of the commission. The report shall set forth the date,
- 11 time and place of the killing, the number of species killed
- 12 [and] the sex of the species[.] and the location of each
- 13 <u>carcass. The commission shall establish a self-reporting system</u>
- 14 that allows a person assigned to remove deer for crop damage
- 15 purposes to report each harvest to an officer of the commission
- 16 <u>via a toll-free telephone number, online application or publicly</u>
- 17 accessible Internet website.
- 18 § 2125. Surrender of carcass [to commission officer].
- 19 Except as otherwise provided in this subchapter, the entire
- 20 carcass, including the head and hide[,] of all big game animals
- 21 and the entire carcass of any other game or wildlife, other than
- 22 raccoons, <u>less entrails</u>, shall be made available, unless
- 23 otherwise directed by an officer of the commission, intact[,
- 24 less entrails,] to any commission officer calling for them[.] or
- 25 <u>delivered to a processor for final disposition. As used in this</u>
- 26 <u>section</u>, the term "processor" means a location specified by the
- 27 <u>commission that is willing to accept donations of animals taken</u>
- 28 under this chapter.

- 3 (a) [General rule] <u>Violations</u>.--It is unlawful for any
- 4 person while acting under the provisions of this subchapter to:

- 6 (8.1) Fail to obtain written permission to hunt on a

- 9 (b) Penalties.--

- 11 (4) A violation of this subchapter pertaining to written
- 12 <u>permission is a summary offense of the third degree.</u>
- 13 Section 4. Section 2303 of Title 34 is repealed:
- 14 [§ 2303. Hunting on Sunday prohibited.
- 15 (a) General rule. -- Except as otherwise provided in this
- 16 title, it is unlawful for any person to hunt for any furbearer
- 17 or game on Sunday.
- (b) Construction of section. -- This section shall not be
- 19 construed to prohibit:
- 20 (1) The training of dogs.
- 21 (2) The participation in dog trials as provided for in
- this title.
- 23 (3) The removal of lawfully taken game or wildlife from
- traps or the resetting of the traps on Sunday.
- 25 (b.1) Exceptions. -- Subsection (a) shall not apply to:
- 26 (1) The hunting of foxes.
- 27 (2) The hunting of coyotes.
- 28 (3) Any hunting which occurs on noncommercial regulated
- 29 hunting grounds holding a valid permit under section 2928(b)
- (2) (relating to regulated hunting grounds permits).

for the costs incurred for testing under this

- 11 § 2314. Trespass on private property while hunting.
- 12 (a) [General rule] <u>Trespass</u>.--A person, while engaged in
- 13 hunting or furtaking, commits an offense if, knowing that the
- 14 person is not licensed or privileged to do so, the person:
- 15 (1) enters or remains on any land of another without
- authorization to do so, when the land is posted in a manner
- 17 prescribed by law or reasonably likely to come to the
- person's attention [or is fenced or enclosed in a manner
- manifestly designed to exclude trespassers; or];
- 20 (2) enters or remains on any land of another without
- 21 authorization and defies an order not to enter or to leave
- 22 that has been personally communicated to the person by the
- owner of the land or other authorized person[.];
- 24 (3) enters or remains on any land of another without
- authorization to do so, when the land is fenced or enclosed
- in a manner manifestly designed to exclude trespassers; or
- 27 (4) subject to subsection (b), enters or remains on any
- land of another without authorization to do so when notice
- 29 against trespass is given by the placement of identifying
- 30 purple paint marks on trees or posts on the property, in

- 1 <u>accordance with 18 Pa.C.S. § 3503(b)(1)(vi) (relating to</u>
- 2 <u>criminal trespass</u>).

- 4 (c) Penalty. -- An offense under this section shall be graded
- 5 as follows:
- 6 (1) A person who violates subsection (a) (1), (3) or (4)
- 7 commits a summary offense of the [third degree.] <u>second</u>
- 8 <u>degree and may result in forfeiture of the privilege to hunt</u>
- 9 <u>or take game or wildlife anywhere within this Commonwealth</u>
- 10 for a period of up to one year.
- 11 (2) A person who violates subsection (a) (2) commits a
- 12 misdemeanor[.] <u>and shall result in forfeiture of the</u>
- 13 <u>privilege to hunt or take game or wildlife anywhere within</u>
- this Commonwealth for a period of three years.
- 15 (3) A person who commits a second or subsequent
- violation of this section within a seven-year period commits
- 17 a misdemeanor, and the second or subsequent violation shall
- 18 result in forfeiture of the privilege to hunt or take game or
- 19 wildlife anywhere within this Commonwealth for a period of

- 23 [§ 2315. Hunting on Sunday without written permission.
- (a) General rule. -- A person required to secure a hunting
- 25 license to hunt commits an offense if, while engaged in hunting
- on Sunday under section 2303(b.1)(4) (relating to hunting on
- 27 Sunday prohibited), the person enters private land without
- 28 obtaining written permission of the landowner, an agent of the
- 29 landowner or lessee.
- 30 (b) Penalty. -- A person who violates subsection (a) commits a

- 1 summary offense of the third degree.]
- 2 Section 8. This act shall take effect in 60 days.
